The System Audit Family Violence Evaluation (SAFE) Project Expanded



Expression of interest

Background

The University of Melbourne, in collaboration with The Royal Women's Hospital, have received Commonwealth National Partnership funding for an expansion of the System Audit Family Violence Evaluation (SAFE) Project. This work will be conducted over 2023 and 2024.

The SAFE Project administered a System Audit Tool (SAFE Tool) at 18 Victorian hospitals and health services between November 2019 and April 2021 to evaluate the impact of the Strengthening Hospital Responses to Family Violence (SHRFV) program, and responses to domestic and family violence more generally across participating organisations. This work also formed an evidence base for how change is occurring in health settings to inform domestic and family violence related policy and practices across Victoria and Australia. Expression of interest process

We are now recruiting 20 *new* hospitals and health services to participate in the SAFE Project Expanded *and* inviting sites who participated in the original SAFE Project to also be part of this work. Participating sites will receive \$5,000.00 each to support staff administer (or readminister) the System Audit Tool.

Responsibilities of participating sites

Participating hospitals and health services will administer (or readminister) the SAFE Tool, or SAFE Lite Tool (for small rural sites). These are System Audit Tools and provide a mechanism for whole-of-hospital evaluation concerning identification and response to patients and staff who experience domestic and family violence across three broad areas: Patient, Staff and Organisational.

Data collection includes audits of clinical files and policies, review of documentation and training, assessment of hospital culture and environment and review of collaborative arrangements.

Participating sites are required to collect data, populate the SAFE/SAFE Lite Tool and provide the completed Tool to the University of Melbourne. Note that the SAFE Tool and SAFE Lite Tool are provided to participating hospitals and health services as an Excel Form (interactive excel file).

Work to administer the SAFE/SAFE Lite Tools at participating sites will be conducted during 2023 and 2024.



Opportunities and benefits for participating sites

Participating organisations will contribute to building the evidence base for a whole-of-hospital approach to responding to family violence thereby informing policy and practice and advocacy for the ongoing sustainability of domestic and family violence programs within the hospital and health service setting.

A final report will be disseminated broadly. This will present results in a de-identified manner and provide an overall summary of the findings and recommendations as appropriate.

Participating hospitals will also receive an individual confidential organisational report that includes their final audit findings. This allows hospitals to understand the contribution of the Strengthening Hospital Responses to Family Violence (SHRFV) program and why the results have or have not occurred. Further, this is an opportunity for hospitals to gain a deeper understanding of which components of the SHRFV program have had the greatest impact in their service, as well as providing practice recommendations for further resourcing, development and action.

Support for participating sites

Professor Kelsey Hegarty, Director, Centre for Family Violence Prevention, University of Melbourne and The Royal Women's Hospital, is overseeing the project and will provide expert support to hospitals and health services. Dr Minerva Kyei-Onanjiri from the University of Melbourne is managing the project; she will provide advice and support to participating hospitals and health services and assist them to navigate the implementation of the SAFE/SAFE Lite Tool.

The SAFE Research Team from the University of Melbourne will also guide participating sites in completion of ethics approval – it is anticipated this will be in the form of *quality assurance/audit/evaluation activity* rather than a full ethics application.

Participating hospitals will receive \$5,000 to support staff to administer (or readminister) the System Audit Tool in their hospital/health service.
